The Book of Constitutions - Cliff's Notes Edition

I bet you thought we were done! Oh no - after a brief hiatus, we're back for the final installment in our series, because we've reached the end.

The very first pages in your presentation volume, and in the methodical digest is the Book of Constitutions. This brief article is a summary of Chapter IV, Sections IX (p. 36 in the presentation manual) as well as Chapter V and VI. In this section, we learn several forms of bad behavior that could get you thrown out of Grand Lodge, and why DDGMs exist (Chapter VI). This appears to stem from Proverbs 3:1-6, rephrased somewhat in the Masonic constitutions.

SECTION IX - Rules to be Observed During the Time of Public Business

The Master's gavel silences everyone; those who still speak should be reprimanded. Everyone keeps their seats until the MW calls to order. At Grand Lodge, members should sit according to their lodge number, and not move around, with the exception of Grand Wardens and other officers. No brother can speak more than twice on the same subject, unless to explain himself or when called on.

Everyone who speaks should stand, address the chair, and should not be interrupted unless he is wandering from the point. Members who are guilty of breaking these rules three times should be asked by the chair to leave the Grand Lodge room for that night. Whoever laughs or hisses at any other brother should be excluded from the Communication, and declared incapable of being a member of Grand Lodge until he publicly owns his fault and is forgiven.

No motions for regulations can be made until they are handed in writing to the Chair, perused by the GM, moved publicly, read by the Grand Secretary, and if then seconded and thirded, it should be immediately considered by the whole. Then the question can be put pro or con. Sometimes counters or ballot boxes may be used, at other times holding up hands or verbal "aye" / "no".

Chapter V - Regulations for Charity to be Observed in the Grand Lodge

The committee on Charity consists of five Past Masters appointed by the GM and others who may be appointed. They meet four times per year, and may hear petitions to relieve distressed brethren. Only registered masons who have contributed to the Grand Charity Fund and were

members of a warranted lodge can be considered and relieved. Sojourners can be relieved by private contributions, as the majority thinks is appropriate.

The committee has the right to dispose of Grand Charity under those restrictions, provided always that no Brother made in a clandestine manner, or who has assisted in a clandestine making, can ever be qualified.

All transactions are to be entered on the record and read by the Chairman before all the members of Grand Lodge, at the Annual Grand Communication.

Chapter VI - Of Grand Visitations and Communications

All lodges should observe the same rules as much as possible.

"Solomon, my son, forget not my law, but let thine heart keep my commandments, and remove not the ancient landmark which thy fathers have set"

And so the GM's duty is to appoint Grand Officers to visit all lodges to see that ancient customs and usages are strictly observed. This laudable duty has become impracticable, due to the size of jurisdictions and number of lodges, and so the Grand Master shall create districts, and allow one or more visitors to each district, who should make faithful report to the Grand Communication.

The Brethren so appointed, shall have a dispensation signed by the GM or his deputy, explaining the nature of their business, whose duty is to visit every Lodge.

The foregoing is the Constitution of Masonry, as compiled and sanctioned by the Grand Lodge of Virginia in 1791.

During the year 1850, the Grand Lodge of New York, "by a compact and resolutions" affected a union with the "St. John's Grand Lodge" of that state, a body that was considered "Clandestine" by every grand lodge in communication with the Grand Lodge of New York. In 1859, a union was affected between the two bodies, and in the same year the Grand Lodge of Virginia objected to the manner in which the two were united. Virginia claimed the members of the rival grand lodge should be "healed" (made legal) before they could be recognized as Masons. In 1860, the deputy grand master of the Grand Lodge of New York, John W. Simons, stated in a report that there was a "a great diversity of opinion" about what the term "healing" meant. He "finally adopted as the safest plan for all concerned, a remaking" of those who had been members of the St. John's body, so he did just that.

The Grand Lodge of Virginia contended Simons was correct and the members of the Phillips Grand Lodge should be treated in like manner. A lengthy report was made in the Grand Lodge of Virginia in 1858, and while no specific action was taken, subordinate lodges in Virginia refused to let Masons from New York enter their lodges. A definite statement had to be forthcoming from the Grand Lodge, so the following resolution was presented and adopted:

Resolved. That the Lodges and Masons, under the jurisdiction of the Grand Lodge, are hereby forbidden and prohibited from holding converse on the subject of Free Masonry with any person hailing from the State of New York, or in any other manner extending masonic intercourse and recognition towards them; and this Grand Lodge feels it to be in its imperative duty to discontinue all Masonic intercourse with the Grand Lodge of New York, until such time as the difficulties new

existing in New York shall be adjusted in accordance with strict Masonic law and usage, as laid down by M. Wor. Jno. W. Simons, the present Grand Master, while acting as D.G. Master.

Resolved. That this regulation shall have full force and effect from its adoption, and continue in operation until the grand Lodge of New York shall revise the union of 1858 with the Phillips' Grand Lodge, and adjust a settlement on the principles and "conditions set forth" when "the matter of the St. John's Grand Lodge was finally disposed of in June, 1860."
